Purpose: The Teachers Advisory Council (TAC) is designed to improve the educational landscape of Kentucky by providing Kentucky's Commissioner of Education with direct input from Kentucky's classrooms. Bridging the gap between policy and practice, the TAC was created to advise the commissioner on educational priorities so that Kentucky's students are well-prepared for any career they choose. The ultimate goal is to have effective teaching in every school, every classroom, every day.

Membership: The Teacher Advisory Council (TAC) is comprised of approximately twenty (20) teacher leaders from across the Commonwealth who contribute crucial, diverse perspectives on education. Four (4) quarterly meetings take place each year. Members are required to attend at least three of the four meetings to remain an active member of the TAC.

The Office of Educational Licensure and Effectiveness coordinates the application process. Teachers are selected and appointed to the TAC for three-year terms. Membership is prioritized to ensure instructional expertise in various disciplines, grade bands, and areas of specialization are represented on the council. Assessments for 2021 -2022



Testing Progress Update

- ACCESS for ELLs[®] (English Language Proficiency exam)
 - Original test window extended
 - 99% tested (online testing)
- The ACT Window 1 (initial testing for most districts)
 - Over 20,000 individual test sessions were completed at the end of the first week of the first online test window.
 - Approximately 100 schools indicated they would test with paper on the March 8 initial paper test date.
- Upcoming Test Windows
 - The ACT Window 2 (makeup testing for some districts): opens March 22
 - Alternate Kentucky Summative Assessment: April 18 May 27
 - Kentucky Summative Assessment: districts' last 14 instructional days







Accountability Beginning 2021 -2022

- 703 KAR 5:270, Kentucky's accountability system became effective.
- For the 2021 -2022 school year, accountability indicators are based on Status only.
- Indicators
 - State Assessment Results in Reading and Mathematics;
 - State Assessment Results in Science, Social Studies and Writing (on -demand and editing/mechanics);
 - Progress on English Language Proficiency;
 - Quality of School Climate and Safety Survey;
 - Postsecondary Readiness; and
 - Graduation Rate







State Assessment Results in Reading and Mathematics (E/M/H)

- Describes the desired level of knowledge and skills as measured on state -required academic assessments.
- Designed to measure how students achieve on Kentucky's Academic Standards (KAS) in reading and mathematics.

State Assessment Results in Science, Social Studies and Writing (on-demand and editing/mechanics) (E/M/H)

- Describes the desired level of knowledge and skills as measured on state -required academic assessments.
- Designed to measure how students achieve on Kentucky's Academic Standards (KAS) in science, social studies and writing.




Progress on English Language Proficiency (E/M/H)

- Status-Individual student growth on the English Language Proficiency Exam from year -to-year
- Change-the difference in school performance of English learners toward English language proficiency
- Includes students currently identified as English Learners
- The English learner progress indicator shall be measured based on a growth value table



Quality of School Climate and Safety (E/M/H)

 Uses perception data from surveys that measure insight into the school environment



 Online student survey administered to all students at every tested grade (3-8, 10, 11)

Note: Opportunity to Learn items were used in 2020 -2021 for information and may continue for that purpose in the future.



Postsecondary Readiness (High School Only)

- <u>Postsecondary Readiness</u> is the attainment of the necessary knowledge, skills, and dispositions for a student to successfully transition to the next level of his or her educational career.
- Postsecondary Readiness Indicator Chart To demonstrate
 postsecondary readiness, high school students must earn a regular or
 alternative high school diploma or be classified as a grade 12 nongraduate AND meet one type of readiness (Academic or Career).
- All students with a G-code in Infinite Campus (IC) and grade 12 non-graduates are included in Postsecondary Readiness and are accountable based on the 100 -day rule.

Federal law requires the greatest emphasis on Reading and Mathematics and English Language progress at elementary and middle schools. At high school, federal law requires emphasis on Reading and Mathematics and Graduation Rate.



Overall Designations

- An overall performance rating for elementary, middle and high schools reported using a color rating system to communicate performance of schools, with red being the lowest rating and blue being the highest rating
- Color ratings to include five performance levels from highest to lowest, Blue, Green, Yellow, Orange and Red



Federal Designations

Comprehensive Support and Improvement (CSI), Targeted Support and Improvement (TSI), and Additional Targeted Support and Improvement (ATSI)

- Fall 2022 reporting will identify schools for CSI to be supported in the 2022 -2023 school year. The next identification of CSI will be in the fall of 2025.
- TSI identification in fall 2022 is based on data from 2021 -2022 only due to COVID-19 interruption of testing.
- ATSI will not be identified in fall 2022.







Minimum N-Count for All Students per School or Student Group

- For inclusion in accountability a minimum -n of 30 per school/student group
- Continue to report in the School Report Card (SRC) at 10 per grade
- Kentucky reports by school level (elementary, middle and high)







Accountability 2022 -2023 and beyond (1/2)

- For the 2022 -2023 school year (fall 2023 reporting), accountability indicators are based on **Status and Change**.
- Status is current year performance and change is improvement from prior to current year.
- For each state indicator, there shall be five status levels ranging from very high to very low, and five change levels ranging from increased significantly to declined significantly.
- The percentile cut scores for status and change levels shall be based on a distribution and shall be approved by KDE and LSAC. Cut scores shall remain in place for at least six years unless existing cut scores no longer support meaningful differentiation of schools as required by ESSA.



Accountability 2022 -2023 and beyond (2/2)

- KDE shall develop an online "dashboard" of system results with color -coded performance levels.
- Status and Change will combine to determine indicator performance rating (color).
- Results are reported for each state indicator, overall performance, status and change by district and school for all students as a group and separately for individual subgroups.
- Overall performance shall aggregate all available data for the state indicators.

Legislative Update

March 15, 2022



Recap

- Less than a month to go!
- 1,165 bills filed
 - 783 in House
 - 382 in Senate
- Unusual number of "shell bills"
- Quite a few bills are moving now

Remaining Priorities

- Budget
- Tax reform
- Everything else
 - School choice, charter schools, CRT-related bills

Budget Process

- HB1
- Senate passed their version last week
- As expected, overall spending on education is lower than the House proposal
- Next step is free conference committee
- There, the chambers agree on the final budget to send to the Gov
- Gov has line-item veto power in the budget
- GA can override a veto with a simple majority vote in each chamber



- HB8 Tax reform bill
- HB9 Public charter school bill
- HB14/HB18 CRT bills
- HB23 Transgender sports
 - 50 cosponsors; limited to grades 6 -12, passed out of committee
- HB28 immunization disclosure.
 - Passed out of the House on a vote of 71 -22. Has not been assigned in the Senate.
- HB31 C.R.O.W.N. Act. Reported favorably from House Judiciary.
- HB33 School facilities bill
 - Among other things, delete reporting requirement for efficient design
 - Voted out of the House, assigned to Senate Education
- HB44 Mental health in district attendance polices
 - Passed out of House, assigned to Senate Education



- HB51 Mask mandates
 - Passed the House on a vote of 56 -35. Assigned to Senate Health & Welfare.
- HB63 Require a SRO by Aug 1, 2022
 - If sufficient funds and personnel are not available, school districts shall fulfill the requirement on a per campus basis as approved by the state school security marshal
- HB126 FAFSA graduation information requirement
 - Passed out of committee, awaiting vote on the House floor
- HB194 High School Equivalency Diplomas in alternative education programs
 - Passed out of Senate Education unanimously and placed on the consent calendar.
- HB226 Companion to SB9.
 - Passed out of the House with House Committee Sub 1; assigned to Senate A&R; Reassigned to Education.

- HB270 Child abuse awareness and prevention instruction; "Erin's Law"
 - Passed out of the House; floor amendment added by sponsor
- HB277 Create a new expedited alternative certification pathway (Option 9)
 - Reported favorably from House Education and awaiting action on the floor.
- HB305 School choice bill. Companion to SB50.
 - Has not been assigned to committee yet; 20 co -sponsors including the Speaker.
- HB397 Waive up to 15 student attendance days for days school districts were closed due to the western Kentucky tornado disaster; consider days waived under this Act as completed employment contract days for school personnel.
 - Passed out of Senate Education unanimously and placed on the consent calendar.
- HB487 CRT bill
 - Introduced late last week; not yet assigned to committee
 - Same sponsor has HB18



- HB522 Would increase the minimum amount for advertising and bidding school building projects from \$7,500 to \$30,000.
- HB527 Establish a student loan forgiveness program for teachers and administrators.
- HB601 Require teachers be compensated for noninstructional planning time within their school day during which they are required to supervise or instruct students.
- HB623 Same as 601 but also expands the program eligibility of the Work Ready Kentucky Scholarship Program to include a program that leads to a bachelor's degree in education in a critical shortage area.



- HB639 Require growth in enrollment to be included in the 2022 -23 school year SEEK calculation utilizing end of year membership numbers, require a loss adjustment to assist districts with greater than 3% loss in student enrollment.
 - On House Education agenda for today.
- HB680 Establish a virtual computer science career academy; direct WeLeadCS to implement the program; establish program requirements.
 - Reported favorably from House Education.
- HB703 Transition the school funding model from using average daily attendance to average daily membership.
- HB704 Establish the Teacher Recruitment Student Loan Forgiveness Program.



Senate Bills of Interest

- SB1– Principal selection & curriculum decisions moved to Superintendent
 - Assigned to House Education.SB9 Early literacy education
- SB9 Read to Succeed Act
 - Would not impact RTA
 - On House Education agenda for today
- SB50 School choice (no co-sponsors)
- SB60 Head Start bill
 - Passed out of the Senate with Senate Committee Sub 1

Senate Bills of Interest

- SB61 Deleting end -of -course examination and ACT benchmark requirements from the early high school graduation program.
 - Reported favorably from House Education; posted for passage on 10/14
- SB83 Transgender sports
 - Reported favorably from Education; posted for passage on 10/14
- SB102 Reporting information on school -based mental health services providers in the district to the KDE
 - Passed out of the Senate
- SB138 CRT-related bill
 - Assigned to House Education



Senate Bills of Interest

- SB151– School breakfast during instructional time
 - On House Education agenda today
- SB215 RTA/RTS bill; same as HB93 which was rolled into HB226
 - Assigned to Senate Education
- SB284 AN ACT relating to financing of school building projects.
 - Assigned to Senate Education
- SB351 Require a school district's COVID -19 masking policy to allow parents to opt out for any reason. Kentucky Department of E D U C A T I O N
 - Assigned to Senate Education

- 179 districts
- 1,281 schools
 - 75%+ of educators shared feedback about their experiences in their schools
 - 4 districts had 100% participation
 - Approximately 90% of districts had >50% participation

1. Staff-Leadership Relationships

Perceptions of faculty and staff relationships with school leaders.

2. Educating All Students

Faculty perceptions of their readiness to address issues of diversity.

4. School Leadership

Perceptions of the school's leadership effectiveness.

5. School Climate

Perceptions of the overall social and learning climate of the school.

6. Professional Learning

Perceptions of the amount and quality of professional growth and learning opportunities available to faculty and staff.

7. Feedback and Coaching

Perceptions of the amount and quality of feedback faculty and staff receive.

8. Resources

Perceptions of the adequacy of the school's resources.

9. Emotional Well-Being and Belonging

Perceptions of educator well being, efficacy, and Kepalunging epartment of
