COMMENTS FROM ROGER MARCUM, KENTUCKY BOARD OF EDUCATION CHAIR: PARTNERSHIPS CARRY THE DAY FOR EDUCATION FUNDING

As part of the April 13 Kentucky Board of Education meeting, we heard an update on legislation passed by the General Assembly and the budget agreement worked out by the Conference Committee. What we knew about the budget at the time of the board meeting was encouraging because the word was that P-12 was not going to undergo cuts.



Since the budget has passed, it has been confirmed that P-12 did not receive cuts. This is no accident because many of you advocated with members of the General Assembly to keep education funding steady over the next biennium.

The board thanks the Conference Committee for its hard work in reaching agreement on the budget and all shareholders who advocated for continued investment in P-12 education. This success illustrates the power of building relationships and consistent messaging.

The board also thanks department staff for their long hours of work during the legislative session to ensure that legislators had data on which to base decisions. Commissioner Pruitt and department staff spent many hours attending committee meetings and talking one-on-one with legislators and other partners.

Now that the session is over, we need to continue the momentum we have built and be supportive of the work to move Kentucky education forward as a new accountability system is designed. The board stands ready to be a partner in this work.

KSD SIGNING CHOIR PERFORMS

At its April 13 meeting, the Kentucky Board of Education was proud to host a performance of the Kentucky School for the Deaf (KSD) Signing Choir. The choir presented its interpretation of three songs through sign language.

NEW ACCOUNTABILITY SYSTEM DISCUSSED

Commissioner Stephen Pruitt and Associate Commissioner Rhonda Sims engaged the board in a discussion about the process for developing a new accountability system to meet the requirements of the Every Student Succeeds Act. Pruitt conveyed that the goal is to produce a system that is fair, reliable, easier to understand and student-focused.

As part of this agenda item, the board heard the presentation that is being given as part of the listening tour, comprised of eleven Town Hall meetings, that the Kentucky Department of Education is holding across the state this spring. Commissioner Pruitt indicated that these meetings are designed to gather feedback to shape the new system and find out what is important to Kentucky's citizens.

ADVANCEKENTUCKY ADDS MORE SCHOOLS

AdvanceKentucky Executive Director Joanne Lang announced the ninth cohort of high schools that will participate in the program that is designed to expand access to and participation and success in Advanced Placement (AP) courses, particularly among student populations traditionally underrepresented in these courses. The new high schools are: Boyd County, Campbellsville Independent, Central (Jefferson County), Elizabethtown Independent, Fleming County, Mason County, Nelson County and Thomas Nelson (Nelson County).

Lang also shared that AdvanceKentucky currently reaches 109 high schools in 79 of the state's 173 districts. She noted that since the program began in 2008, the number of students taking AP courses and earning qualifying scores has more than doubled. Lang went on to point out that data confirm students who participate in AdvanceKentucky are significantly more likely than their counterparts to be prepared for and attend college, earn higher GPAs and graduate in four years.

NEW DISTRICTS OF INNOVATION NAMED

Three new Districts of Innovation were named by the board at its April meeting. These are Boone County, Corbin Independent and Metcalfe County.

KRS 156.108 and 160.107 allow school districts the opportunity to request exemption from certain administrative regulations and seek waivers of local board policy from the Kentucky Board of Education in order to improve student learning. Each district received approval of selected waivers that will enhance their instructional program.

Associate Commissioner Laura Arnold was presented with the Kevin M. Noland Award by Commissioner Stephen Pruitt. This award recognizes a Kentucky Department of Education (KDE) employee for significant service to schools and for providing an inspiration for education. KDE staff nominate individuals for consideration.

Arnold oversees the 42-staff members in the Office of Career and Technical Education as well as 650 staff members at the 53 Area Technology Centers. She has served as program manager, policy advisor, division director and now associate commissioner at KDE.

Matt Chaliff, who nominated Laura, said that "her greatest achievement has been building ties between career and technical education and groups such as the Kentucky Career and Technical College System, the state Chamber of Commerce, the Kentucky Workforce Innovation Board and hundreds of business and industry partners." Chaliff continued that "students are leaving better prepared for the world of work because of her work to make these kinds of connections."

The board established this award to honor former Interim Commissioner, Deputy Commissioner, Associate Commissioner and General Counsel Kevin M. Noland, who served the department for approximately 18 years.
