COMMENTS FROM MARY GWEN WHEELER, CHAIR KENTUCKY BOARD OF EDUCATION

The Kentucky Board of Education (KBE) held its regular meeting on October 4 in Frankfort where it heard and approved four (4) administrative regulations governing public charter schools in Kentucky. The regulations address requirements pertaining to the following:



- student application, lottery and enrollment;
- the evaluation of charter school authorizers;
- the process for a charter school's appeal of an authorizer's decision; and
- the petition, conversion and operational processes for conversion charter schools.

The board also met on the evening of October 3 for a work session to discuss Commissioner of Education Stephen Pruitt's self-evaluation. A summary of the board's discussion was shared with Commissioner Pruitt during the following day's regular agenda. The board expressed its satisfaction with the Commissioner's performance over the last year, citing many leadership strengths, including his collaborative approaches to the new accountability system redesign, improvements at the Kentucky School for the Blind and the Kentucky School for the Deaf and the development of the new Kentucky Department of Education (KDE) strategic plan. The need for a continued emphasis on closing achievement gaps, the implementation of public charter schools and the new accountability system, state standards and assessments, early childhood education and innovation was noted.

PRESENTATION OF KBE AWARDS

The board was honored to recognize three (3) award winners during the October regular meeting.

2017 David Karem Award

In 2017 the Kentucky Board of Education established its newest award, known as the David Karem Award. This award is to be given annually to a state policymaker, education leader, or citizen who has contributed to the improvement of education through venues such as national commissions, task forces, or other significant boards and organizations. Mr. Karem was a respected legislator and seven-year member of the Kentucky Board of Education.

Dr. Blake Haselton, a Superintendent in Residence and Associate Clinical Professor at the University of Louisville, was chosen as the first-ever recipient of this award. His contributions to education in Kentucky have spanned more than four decades and included numerous state and national leadership roles.

2017 Joseph W. Kelly Award

In the year 2000, the Kentucky Board of Education established the Joseph W. Kelly Award to be conferred annually on a businessperson who has offered outstanding leadership and service toward promoting school improvement and equity of educational opportunity for Kentucky's children. Mr. Kelly was a respected businessman and seven-year chairman of the Kentucky Board of Education.

This year's winner, *Mr. C. Ed Massey*, has served as a member of the Boone County School Board for 21 years and is employed as a local attorney.

2017 Kevin M. Noland / Mary Ann Miller Award

The Kentucky Board of Education (KBE) established the Kevin M. Noland Award in 2008. It was established to honor former Interim Commissioner, Deputy Commissioner, Associate Commissioner and General Counsel Kevin M. Noland, who served the Kentucky Department of Education (KDE) for approximately 18 years. The award recognizes a KDE employee for significant service to Kentucky's public schools and for providing inspiration for education. This year, at the request of the KBE, the award was renamed as the "Kevin M. Noland / Mary Ann Miller Award", in honor of Ms. Miller's approaching retirement and nearly thirty years of service to both the KBE and KDE.

The individual selected by the committee as the 2017 Kevin M. Noland and Mary Ann Miller Award winner was *Mr. Jonathan Paul Bogar*, a CTE welding instructor at the Belfry Area Technology Center in Pike County.

APPROVAL OF THE 2018-2020 BIENNIAL BUDGET REQUEST

Robin Kinney, KDE Associate Commissioner for the Office of Finance and Operations, and Charlie Harman, KDE Budget Director, provided KBE members with a final list of additional budget items that were proposed for inclusion in the agency's 2018-2020 biennial budget request. There was consensus among board members on the importance of each item included in the proposal, as well as acknowledgement of the challenging fiscal environment that currently exists within the state. The board ultimately set priority for:

• SEEK transportation;

- Statutorily-required items related to assessment and accountability (specifically, industry certifications, AP/IB exams and college readiness exams); and
- Full-day kindergarten.

The board approved all items recommended by staff. The formal budget request will be submitted to the Governor's Office in November.

BOARD HEARS UPDATE ON 2016-2017 STATE ASSESSMENT RESULTS

The board voted to amend its agenda the morning of the meeting to hear a brief update from KDE staff about the 2016-17 assessment results. Rhonda Sims, KDE Associate Commissioner for the Office of Assessment and Accountability, as well as Division Directors Kevin Hill and Jennifer Stafford, presented this item. The presentation provided information related to the transition timelines from the old assessment system to the new system designed under the Every Student Succeeds Act (ESSA), changes in public reporting for 2017, assessment changes and highlights of the overall state results.

Generally, KDE staff reported that assessment scores remained flat across the state. Slight increases were noted in the areas of achievement, graduation rate, ACT scores, and the number of students taking Advanced Placement (AP) tests (particularly low-income students) and those earning qualifying scores. It was stressed that significant achievement gaps still persist for many of Kentucky's students. Board members expressed the urgency for closing such achievement gaps by placing a stronger emphasis on and support for effective instructional and intervention strategies. Kentucky's new accountability system and long-term ESSA goals, which become effective in the 2018-2019 academic year, place an unprecedented emphasis on achievement gap closure for the state.
