KENTUCKY BOARD OF EDUCATION – RETREAT August 1, 2018

The Kentucky Board of Education held a retreat on Wednesday August 1, 2018, at the Kentucky Chamber Office located at 464 Chenault Road, Frankfort, Kentucky. The Kentucky Board of Education (KBE) conducted no business during this meeting.

I. Call to Order

Chair Milton Seymore called the Kentucky Board of Education Retreat to order at 9:05 a.m. ET.

II. Roll Call of KBE Members for Orientation

III. KY Stats –

Dr. Kate Akers presented an informational overview of the agency.

She stated KYStats works to pull everything together into one system and connect all the pertinent relationships among and between data. Dr. Akers provided an in-depth review of the Kentucky High School Feedback Report. She shared the report utilizes data from the Kentucky Longitudinal Data System (KLDS), which includes data from the following Kentucky agencies: Department of Education, Council on Postsecondary Education, Higher Education Assistance Authority, and Unemployment Insurance.

President King stated only twenty (20%) percent of students completing remedial courses at the postsecondary level move forward. He shared a new model of co-requisite classes with targeted assistance to improve retention and completion of degrees.

Dr. Akers stated Kentucky has a flat college-going rate.

Dr. Lewis stated early postsecondary opportunities enable a much greater likelihood of completion.

Dr. Akers presented an overview of the Kentucky Skills Report that assists policymakers, practitioners and the public when making education and workforce decisions. She shared the report utilizes three components of education and workforce development in Kentucky: Historic Supply, Current Employment Outcomes, and Future Demand.

Dr. Lewis stated central to our work at KDE is CTE's alignment to "actual" workforce demands. He shared we are nowhere near where we need to be in terms of Career Counselors.

Members discussed opportunities to disseminate information to parents and community members – educate community at-large regarding viable career pathways. Amanda Stamper commented there should be a statewide campaign to get the message out about the data.

IV. KBE Vision and Mission - Chief Performance Officer Karen Dodd

Ms. Dodd presented discussion items around the KBE vision and mission for the members to explore.

V. Chamber President Dave Adkisson presented an overview of the Kentucky Chamber's focus as a major catalyst, consensus builder and advocate for a thriving economic climate in Kentucky. He shared the Kentucky Chamber has over 68,000 employers.

Mr. Adkisson stated the Kentucky Chamber has long-standing involvement in efforts on behalf of improving education at all levels beginning in the 1980's the Project 21 Report, the 1990 KERA Legislation, the 1997 Postsecondary Education reform, and have been active in supporting K-12 Academic Standards, the new Accountability model and in 2017, Public Charter Schools, as well as Essential Skills legislation.

VI. Ethics Training with Executive Branch Ethics Commission – Katie Gabhart

Ms. Gabhart stated the mission of the Executive Branch Ethics Commission is to promote the ethical conduct of elected officials, officers and other employees in the executive branch of state government. The Commission seeks to fulfill its mission through:

- administering a program of training and education on the code of ethics;
- providing guidance to state employees concerning their ethical conduct;
- enforcing the provisions of the code of ethics;
- interpreting the code of ethics through the issuance of advisory opinions;
- registering executive agency lobbyists; and
- recommending legislation to the General Assembly.

All members completed the training and signed the appropriate Ethics Commission forms certifying training completion.

VII. Budget and Finance Review – Associate Commissioner Robin Kinney

Associate Commissioner Kinney presented an in-depth look at the Kentucky SEEK formula and school funding criteria/processes.

VIII. Review of KBE Policy Manual

Chair Seymore recommended the following technical corrections be made:

- Update the title of the *Policy Advisor* to *Executive Director for Kentucky Board of Education*
- Omit "Beginning in 2013" from MEETINGS section
- Add in SPEAKING ON BEHALF OF THE BOARD: Additionally, the chair shall serve as the official spokesperson for the board and shall represent the Board in public and at ceremonial events. When the Chair is unable to attend such events, he/she shall designate a Board representative.
- Add in RESPONDING TO WRITTEN CORRESPONDENCE AND E-MAILS: In the event a Board member responds individually to a sender, the Board member's response shall indicate he/she is not speaking for the Board.
- Add in OFFICERS: The vice chair shall serve a non-voting ex officio member, as well as the Chair of all committees.
