#### **Minutes**

The Kentucky Board of Education (KBE) held its special meeting on Tuesday, March 17, 2020, at 1:00 p.m. ET, 300 Sower Blvd. Room 532, in Frankfort, Kentucky. The board conducted the following business:

### I. Call to order

Sharon Porter Robinson called the meeting to order at 1:03 p.m. ET.

Cody Pauley Johnson announced that the meeting is open to the public and subject to the requirements of the Open Meetings Act.

### II. Roll call

Sharon Porter Robinson asked for a roll call of members. The following members were present: Cody Pauley Johnson, Sharon Porter Robinson (virtually) and Lee Todd.

KDE Interim General Counsel Todd Allen stated a quorum was present.

# III. Closed session pursuant to KRS 61.810(1)(n) to Evaluate Vendor Oral Presentations Pursuant to KRS 45A for Procurement of a Search Firm for the Next Commissioner of Education
