Financial Disclosure for Visiting International Teachers in Kentucky

Revised December 2024

Per regulations of the US Department of State's Exchange Visitor Program (Federal Register-Department of State 22 CFR Part 62 Exchange Visitor Program), "Sponsors must provide on their main Web sites and in their recruiting materials a general summary of fees and other costs for the program. This summary should include, but not be limited to, the sponsor fee; foreign or domestic third party or partner fees; visa fee; the Student and Exchange Visitor Information System (SEVIS) fee; insurance costs; estimates for food, housing and local transportation costs; expected work-related deductions; and estimates or ranges for all other fees charged for and significant general costs related to participation in the teacher exchange program."

Sponsor Fees, Third Party Fees and Partner Fees

The Kentucky Department of Education does not charge its J-1 visa recipients any sponsorship program fees or pass on any sponsorship-related costs to them. Additionally, exchange visitors sponsored by the Department are not subject to any foreign or domestic third-party or partner organization fees.

Services provided by the Department to exchange visitor teachers free of charge include mailing DS-2019 forms, processing extensions, and

SEVIS and J-1 Visa Fees

Before you can apply for a visa to enter the United States as an exchange visitor, you need to pay the I-901 Student and Exchange Visitor Information System (SEVIS) fee, which is currently USD \$220. The cost to apply for the required J-1 visa is USD \$185. There is an additional cost for each dependent's J-2 visa. Exchange Visitors will also have to pay for an international credential evaluation fee (+ \$176-\$220) required for securing a Kentucky teaching license. There is no fee for the limited one-year licensure.

Federal Insurance Contributions Act (FICA)

FICA is a U.S. federal payroll tax. It is deducted from each paycheck. From your wages, 7.65% will be deducted for FICA with 6.2% going to Social Security tax and 1.45% to Medicare tax.

Teacher Salaries in Kentucky

Unlike the compensation practices in many foreign countries, salaries are not uniform for all teachers in the United States. Salaries vary greatly across each state, including Kentucky, and they are determined by local school districts and educational service centers based on two factors:

- Level of educational attainment (university degree); and
- Years of full-time, formally-recognized experience.

During the 2022-2023 school year:

- Visiting teacher salaries in Kentucky ranged from \$35,000 to \$67,000; and
- The average visiting teacher salary was \$43,825.

Important: Salaries quoted are gross salaries before any deductions are made.

Notes

In addition to these costs, most visiting teachers will have to pay refundable deposits on rental properties and for some utilities since they will not have an established credit history in the U.S. New visiting teachers coming to Kentucky spend between \$2,500 and \$5,000 of their own funds on initial expenses related to housing, transportation, utilities and other miscellaneous initial expenses.
