#### **KY Homeless Services new collection**

The Infinite Campus.2239 Nov. release included a new data collection labeled KY Homeless Services. The new collection is not state mandated but is a new option for districts to collect services such as enrollment, academic and enrichment support provided to students identified as homeless. Homeless students are identified by local district liaisons using a definition from the federal <a href="McKinney-Vento Law">McKinney-Vento Law</a> that states, "homeless children and youth mean individuals who lack a fixed, regular and adequate nighttime residence..." While the new KY Homeless Services section is optional, widespread adoption will be mutually beneficial as the data transfers with the student as a *Summary Report* and the fields are available for reporting via ad-hoc functionality.

Additionally, the KY Homeless Services section will offer the optional Homeless Youth and Children Addendum to Services Form. The form will allow documentation of students' strengths and needs; the form is scheduled to be included in the Dec. 14, Infinite Campus 2247 release.

Screenshots, data element names and descriptions have been added to the <u>Data Standard Homeless Children and Youth</u>. Section B of the data standard covers the KY Homeless Services and Section C covers the Addendum to Services Form.

#### **December 1 Child Count**

To assist with the preparation of the December 1 Child Count, the Office of Special Education and Early Learning has created a short <u>Beginning of the Year Child Count Video</u> that provides step-by-step directions for completing this report. Additional information is also listed below. If you need additional support with December 1 Child Count data, please contact Amy Patterson by email.

IDEA Dec 1 Child Count Reporting - Due the first Friday following Dec. 1 (Dec. 2)

- District personnel should review data in the IDEA Dec 1 Count Extract in Infinite Campus to ensure all enrolled students with individual education plans (IEPs) appear on the report with accurate demographic data. Pathway: KY State Reporting/IDEA Dec 1 Count Extract.
- On Friday, Dec. 2, after 4 p.m. (ET), district personnel should not make any changes affecting the IDEA Dec 1
   Child Count Report
- KDE will run the official *IDEA Dec 1 Child Count* report between 4 p.m. on Friday, Dec. 2 and 8 a.m. (ET) on Monday, Dec. 5. The following additional steps will also be taken on Dec. 5:
  - The KDE will publish the data in the official Infinite Campus report found under KY State Reporting/KDE Reports/IDEA Dec.1 Federal Submission Validation.
  - Directors of Special Education (DoSEs) will be asked to review the data in the *IDEA Dec 1 Federal* Submission Validation Report for accuracy and completeness. District personnel should email the <u>Special</u> <u>Education data manager</u> within the Office of Special Education and Early Learning with any concerns.
  - KDE will send an email survey link to all DoSEs to verify that data in the IDEA Dec 1 Federal Submission Validation Report is accurate.

# Student Locator enhanced to prevent duplication of student records

With the Dec. 14 <u>Campus.2247</u> release, Student Locator will be enhanced to include Birth Date as a required field to alleviate duplication of students when a new student is enrolled into the system. When searching for a student, the birth date field must be entered to activate the search button for <u>Student Locator</u>. The Birth Date field is in addition to other required fields that include Last Name, First Name, Gender or State ID.

## **Duplicate student records cleanup**

Each month, districts should run the <u>Duplicate Students Search Report</u> to identify duplicate student records in Infinite Campus. Use the <u>Combine Person Tool</u> to combine verified duplicate records. Tool rights to the Combine Person Tool should be restricted to a select few in the district and extreme care taken when using the tool. The <u>Duplicate Students Search Report</u> can be found under Student Information/Reports/Duplicate Students Search. The Combine Person Tool is available under System Administration/Data Utilities/Combine Person.

Use the new <u>Google SSID Issues Form</u> to submit SSID issues such as duplicate SSIDs, blended records, pending SSIDs or syncing. A Google account is not required to use the form. The form requires the contact's name, email, district name, issue type and at least one SSID. There is an option at the bottom of the form to send a copy of the submission form to the submitter's email.

# FRYSC access rights recommendations

To ensure Family Resource/Youth Services Centers (FRYSC) information is correctly entered into Infinite Campus, FRYSC coordinators must have appropriate tool rights for access. ## **Benchmark reports**

The KDE benchmark reports provide a longitudinal view of student's performance on summative assessments and identifies whether the benchmark was met on the latest summative assessment. The reports pull assessment data from State Edition to include results for students who tested in another district. The reports are run by subject for mathematics, reading, science, social studies, or writing (English) and include results from the Kentucky Summative Assessments (KSA), Kindergarten Readiness, American College Testing (ACT) and Scholastic Aptitude Test (SAT) when available. There are three variations of the benchmark reports. Select the report hyperlink below to view the relevant quick reference card that includes the KDE contact, report sample and suggested report uses.

- 1. <u>Benchmark Report</u> includes all students with a primary enrollment in the selected school year with indicators for economic disadvantaged, special education, English learner, and gifted and talented. The suggested users are principals, counselors, intervention coordinators and district assessment coordinators.
- Gifted Benchmark Report only includes students identified as gifted in the selected gifted category (General Intellectual Ability, Specific Academic Aptitude in Math, Science, Social Students, or Language Arts). Suggested users are principals, counselors, and gifted coordinators.
- 3. <u>Homeless Benchmark Report</u> only includes students identified as homeless. In addition to assessment data, the report includes primary nighttime residence, an unaccompanied youth indicator, and the absentee percentage for the selected school year. Suggested users: principals, counselors, DDPs and homeless coordinators.

Users must be granted access by the KSIS administrator before they can access these reports. The KSIS administrator must use the <u>Custom Tool Placement Editor</u> to make KDE reports available for those using the "New Look" of Campus.

Before sharing the information with others, please remove sensitive indicators such as the homeless indicator, economically disadvantaged, and student groups.

## Check course setup now for next year's School Report Card

Several reports are available to ensure proper course set up. Proper course set up is important for many reasons including properly awarding student scholarship money for advanced coursework, School Report Card and other reporting purposes.

The QA Courses Report (KY State Reporting/KDE Reports/QA Courses) should be run during the current school year to ensure proper course set up for all courses. Users must be granted access by local KSIS administrators to be able to see this report. Running the QA Courses Report is especially important to correct any errors on advanced coursework courses which could affect student scholarships, and reporting of advanced coursework and exams on next year's School Report Card.

The Advanced Coursework and Exams Report can be run to check data pulled for the Advanced Coursework section of the 2022-2023 School Report Card though course completers, test takers and qualifying scores will not show until the completion of the school year and upon receipt of final test scores. All course information on transcripts should match the course set up in Infinite Campus. Data needs to be in accurate order for advanced coursework and exams information to be pulled correctly for School Report Card, transcript and KEES reporting.

The <u>School Profile Courses Report</u> (KY State Reporting/KDE Reports/School Profile Courses) provides information on courses that populate the School Profile section of School Report Card. Running the *(Continued on page 4.)*

## **KECS 2023-2024 course codes view coming early Dec.**

In early Dec., the new and improved Searchable State Course Codes Database (SSCCD), integrated into the Kentucky Educator Credentialing System (KECS), will include an updated view for the 2023-2024 school year. There are several minor changes to both Career and Technical Education (CTE) and academic courses.

Changes for CTE Courses include two new courses as well as four deprecated courses:

- 332002 Engineering Mechanics for 3D Printing and 332003 Additive Manufacturing Applications have been added for the 2023-2024 school year.
- 470470 Master Medium/Heavy Diesel Truck Service Technology (MTST) Section A, 470471 Master Medium/Heavy Diesel Truck Service Technology (MTST) Section B, 470523 Master Automobile Service Technology Section A and 470525 Master Automobile Service Technology Section B have been deprecated for the 2023-2024 school year.

Changes to academic courses primarily include name and course description updates for Advanced Placement (AP) and International Baccalaureate (IB) courses to keep in alignment with official names and descriptions coming from the College Board and International Baccalaureate organizations. Several Visual and Performing Arts (VPA) courses received slight name updates to better reflect VPA nomenclature. A new course code 270510 AP Pre-calculus is available for the 2023-2024 school year.

For a detailed list of course code changes, see the <u>2023-2024 Course Code Changes spreadsheet</u>. (This spreadsheet will be updated 12/5.) Recommendations for replacement codes can be found on the <u>Deprecated Course Codes and What to Use Instead spreadsheet</u>. Both sheets include historical changes from the 2016-2017 school year to the present.

The <u>Course Codes Frequently Asked Questions</u> document is an excellent resource to help new and returning course codes contacts with proper course code usage.
